MOTION BY LUKE BURD AND SECONDED BY BETH HAGEN TO APPROVE THE CORRECTED ORDERLY ANNEXATION BETWEEN THE CITY OF MCINTOSH AND KING TOWNSHIP PURSUANT TO MINNESOTA STATUTES, SECTION 414.0325. PASSED UNOPPOSED. JORDAN GUNUFSON ABSTAINED FROM VOTE.
